2. BID PRICE

- a. Corrections, if any shall be made by crossing out, initialing, dating and rewriting.
- b. All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- c. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d. The prices shall be quoted in Indian Rupees only.
- 3. Each bidder shall submit only one quotation.
- 4. Bidder should submit the following with quotation, Tender not accompanied by this document, will be summarily be rejected;
 - a. Self-Declaration in case of proprietor/Authorization in case of partnership firm/Copy of resolution adopted by Directors in case of Limited/Pvt. Ltd. Firms.

- b. EMD amounting to Rs 6,000/- (Rupees Six Thousand Only), validity of EMD will be up to the validity of the Tender.
- c. Bidder should have at least three years' experience similar type of work with the Govt. /reputed Institutions. Performance certificate from such Govt. Organisation/Institution for the last 3 years in this regard must be attached with the bid document.
- d. Undertaking as per Annexure -II.
- e. Copy of Income tax return for the financial year 2013-14/latest.
- f. Copy of PAN card of firm / proprietor.
- g. Valid DVAT registration certificate / TIN No. Certificate./Service Tax Registration Certificate as applicable.
- 5. VALIDITY OF QUOTATION:

Quotation shall remain valid for a period of 60 days after deadline date specified for submission. Quotation documents must be signed by the bidder with stamp of the firm.

6. EVALUATION OF QUOTATIONS;

Delhi State AIDS Control Society shall evaluate and compare the quotations determined to be substantially responsive i.e. which

a. are properly singed; and

b. Confirm to the terms, conditions, and specifications.

The quotations would be evaluated for all the items together.

7. AWARD OF CONTRACT

The DSACS will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotations price.

- Notwithstanding the above, Project Director, DSACS reserves the 7.1 right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- Project Director, DSACS reserves the right to increase or 7.2 decrease the items at any time prior to the award of the contract.
- The bidder whose bid is accepted will be notified for the award of 7.3 the contract by DSACS prior to the expiry of the quotation validity period. The terms of the accepted offer shall be incorporated in the work order.
- 8. If the firm fails to perform the work as per work order/specifications of the tender/satisfactorily, a penalty will be levied as decided by the competent authority, DSACS, subject to maximum of 10% of the total contract value.

- 9. The tender should be accompanied by earnest money of Rs. 6,000/- (Rupees Six Thousand only) in the form of Demand Draft/Pay Order in favor of "Project Director, Delhi State AIDS Control Society". Tender not accompanied by Earnest Money will summarily be rejected.
- 10. The Earnest money of unsuccessful bidders shall be refunded soon after the final acceptance of the tenders without interest after receipt of the written request of the bidder(s). The earnest money shall be forfeited in the event of withdrawal of the tender within the original validity once submitted or in case a successful bidder fails to perform the work within the period specified.
- 11. The scheduled dates for training mentioned above are tentative and it can be pre-pond/post-pond or cancelled.
